Ballot Access Goals & Deadlines

Illinois Petitioning Window:

(February 25, 2026 - May 18-26, 2026)

Illinois District 112 Signature Requirement:

(2,600 minimum)

Team Cottingham's Goal:

(3,000+)

- We will need to collect roughly **1,000 signatures (or more) a month.** (Roughly 3 months to work with)
- We will collect **additional signatures** because we need a buffer to combat disqualification.

Who Can Circulate & Sign Petitions in Illinois?

Who can circulate:

1. The circulator must be **18 years old.**
2. The circulator must be a **United States citizen.**
3. The circulator **does NOT have to be a resident of Illinois or IL House District 112.**
4. **Circulating a petition for a Democratic/Republican or another Independent candidate in the same election cycle will invalidate the circulator's petitions.**

Who can sign:

1. The petitioner must be **18 years old.**
2. The petitioner must be a **current resident of the State of Illinois.**
3. The petitioner must be a **registered voter in the State of Illinois.**
4. The petitioner must be a **current resident of IL House District 112.**
5. **Voting in the Democratic or Republican primary in 2024 will NOT invalidate the petitioner's signature.**
6. **Signing a petition for a Democrat, Republican, or another Independent candidate for the same office will invalidate the petitioner's signature.**

There are plenty of other ways one can contribute to our statewide petition initiative such as providing a place or business to petition at, providing resources such as paper/clipboards/pens, or by rallying your friends & family to help out as well. This

goes for all Illinois residents from within and outside of IL House District 112, & volunteers from neighboring states as well.

The Importance of Notaries

When it comes to petitioning in **Illinois**, the notary public is the most important role one can take in a local petition initiative. Like in many other states, **Illinois's Secretary of State requires that all petition forms be properly notarized prior to their final submission.**

Roles of the Notary Public

- While many assume that the notary's job is to notarize all of the signatures on the petition, that is false.
- The role of the notary is to **ensure that the circulator/affiant has properly signed the circulator's affidavit while in their presence.**
- The notary also **certifies that the information found within the petition is accurate.**

How to Become a Certified Notary in Illinois

According to the Secretary of State's website (**link below**), to become a notary in the state of **Illinois**, one must complete these steps.

What is a Complete Signature?

For a signature to be considered complete, it must contain the following:

1. **Signature of the petitioner** that **matches the signature on their driver's license & voter registration card.**
2. The **petitioner's name in print.**
3. The **full registered voting address** of the petitioner, which **must include their street number and street name.**
4. The **city/town/village** of the petitioner.
5. The **county** of the petitioner.

Here is an example of what a complete signature should look like.

Fatal Mistakes:

- The **signature does not match** what is on their driver's license & voter registration card.
- The **registered address is incorrect.** (Street address & city/town/village must be precise)
- The **county does not match** the registered address.

How to Fix & Prevent Mistakes

- **If a mistake is made by the petitioner** while filling out their information on the petition, **simply strike through the entire line and move on to the line below it to start over.**

- **Stray Mark Rule: DO NOT cross out any text** or **allow any rips or tears** to be made to the petition form, for allowing such will result in the **INVALIDATION OF THE ENTIRE PAGE.**

How to Prevent Fraud

- As the **circulator of the petition**, **you are not permitted to correct mistakes made by the petitioner**, for **this is considered fraud** and will **INVALIDATE THE ENTIRE PETITION.**
- As the **circulator of the petition**, **you cannot allow someone to sign for another person**, for **this is also considered fraud** and will **INVALIDATE THE ENTIRE PETITION.**
- As the **circulator of the petition**, **you cannot allow one person to sign for members of their family**, for this is called **Family Fill-In, which is also considered fraud** and will **INVALIDATE THE ENTIRE PETITION.**
- As the **circulator of the petition**, **you must keep those who are signing your petition within your line of sight at all times**, which will **prevent fraud and other fatal mistakes** from being made.

These examples of **petition fraud by hand-of-another could be detrimental** to the success of our petition drives, which is why it is of great importance that we train our circulators to **avoid these fatal mistakes.**

How to Properly Collect Signatures

1. **Locate a place** to circulate your petition or host a petition drive.
2. **Wear your campaign gear or colors!**
3. **Approach people** in a friendly manner and ask, “*Are you a registered voter in the state of Illinois?*”
4. **If they say yes, ask them this.** “*Would you like to sign our petition to have Andrew Cottingham on the ballot this November?*”
5. **If they say yes, ask which IL House District they are from. If they say no or have signed already, thank them for their time.**
6. **If they are from IL House District 112, have them sign the petition.**
(Answer any questions / assistance) **If they are not from IL House District 112, politely inform them that only residents of District 112 can sign; however, they can support the campaign through volunteering and donating.**
7. **Verify their signature & information!**
8. **Thank them** for signing the petition, and **if they’re enthusiastic to help, ask them if they’d like to volunteer or donate as well.**
9. **(See Pages 11-12 for further instruction)**

IMPORTANT NOTE: You **MAY NOT** pay or provide anything of value or misrepresent the purpose & subject of this petition to **induce a person to sign!**

Where Should I Circulate my Petition?

Petitions should be circulated in areas where:

1. **Public property**
2. **There are many registered voters.**
3. **There is likely to be higher support for Mr. Cottingham.**
4. **There is high foot traffic. (public spaces & private places with permission*)**

***Marsh v. Alabama* – You must first ask permission from private property owners to circulate petitions on their property.** (They can remove you from their property at any time for any reason, or even no reason*)

Challenges to Expect in Illinois

- We fully **expect legal challenges** to be made against our signatures by either of the two major political parties.

Signing the Affidavit

As a circulator (affiant), not only is it your duty to **ensure that all the signatures you collect are both complete & valid** and to **prevent fraud**, but it is also your duty to **ensure that the circulator's affidavit is filled out correctly** as well.

Step 1: After you collect your last signature, you sign & provide your registered address on the lines provided below. (MUST be done in the presence of a notary public)

Step 2: After signing the affidavit in the presence of a notary public, you will give your petition to said notary, who will fill out the remaining information at the bottom of the form, which will officially notarize your petition!

- You **cannot notarize your own petition** if you are a notary.

- Whichever method you choose, please **ensure that the package is waterproof, durable, and discreet to prevent any damage or theft** from occurring.




Maps of IL House District 112

Illinois House of Representatives District 112 starting January 11, 2023


Click a district to compare boundaries.




